Old Business

NRA 3 Gun Experience (3GE)

Bob Jones reported that all firearms purchased for the 3GE will be shipped to Ron Fox who will act as the FFL.

Quotes and materials that has Bob secured include:

- 2 Remington Express model 870 12 gauge tactical shotguns with 18" barrels.
- 2 S&W MP-15 .22 LR rifles.
- 2 S&W MP 22 pistols plus magazines.

- MGM will supply ribbons
