### **NRA 3 Gun Experience (3GE)**

Bob Jones discussed hosting a NRA 3 Gun Experience (3GE) with a NRA representative and several firearm and ammunition dealers. ECSA would be eligible for a \$1500 subsidy from the NRA.

Quotes and materials that Bob secured include:

- 5000 rounds of .22LR from CCI
- 2 Remington Express model 870 12 gauge tactical shotguns with 18" barrels at \$296/each.
- 2 S&W MP-15 .22 LR rifles at \$294/each.
- 2 S&W MP 22 pistols plus magazines for \$272/each
- NRA T-shirts
- MGM will supply ribbons

Total cost ~ \$1724

Bob proposed holding one match per month on the 3rd Saturday beginning in April 2018. The 3GE shoots would emphasize training, safety, and education and be divided in to three divisions:

- Peewee ages 10-13
- Junior ages 14-17
- Adult ages 18+

On a motion by Doug Wickre and seconded by Ken Terrill, the Board authorized no more than \$2000 to buy 3GE firearms and ammo.

## **New Business**

### **2017 Friends of NRA Banquet**

The Board voted again to purchase a \$2500 Pioneer sponsorship. The firearm voted on is a Ruger 1911 Lightweight Commander on .45 caliber.

### **Revision to Range Operations Guide**

On a motion by Ken Terrill and seconded by Bob Jones, the board voted to revise the Range Operations Guide to prohibit Tannerite targets at the range except by permission of board. The change is prompted by the extreme fire danger at the range.

## **Good of the Order**

### **Senate Bill 719**

Gina Birkmaier discussed Senate Bill 719 which would create an "Extreme Risk Protection Order" (ERPO) that could be obtained by a law enforcement officer, family member, or household member to deprive someone of their Second Amendment rights without due process of the law.

A summary from the Oregon State Legislature website (<https://olis.leg.state.or.us/liz/2017R1/Measures/Overview/SB719>) states ORS 719:

“Creates process for obtaining extreme risk protection order prohibiting person from possessing deadly weapon when court finds that person presents risk in near future, including imminent risk, of suicide or causing injury to another person.”

Persons so inclined were invited to sign a petition being circulated throughout the state to oppose ORS 719.

### Gun of the Month

Bob Jones brought in a Swiss K-31 rifle in 7.5x55mm with bayonet. These rifles were commonly issued to Swiss citizens to keep in their homes in support of local militias. The name of the Swiss citizen to whom this gun belonged is in the gun's butt stock.

From Wikipedia:

The **Karabiner Model 1931 (K31)** is a magazine-fed, straight-pull bolt action rifle. It was the standard issue rifle of the Swiss armed forces from 1933 until 1958 though examples remained in service into the 1970s. It has a 6-round removable magazine, and is chambered for the 7.5x55mm Swiss, a cartridge .308 Winchester cartridge.
