Insurance

The cost of insurance was raised at the Board meeting. On a motion by Bill Oliver and seconded by Ken Terrill the board voted to ask our insurance provider to come to the June meeting to discuss ECSA insurance policies.

NRA Foundation Scholarships

Doug Wickre reported that the NRA foundation awarded \$30K in scholarships this year. Locally, Riley Gray was awarded \$4K and Teagan Miller was awarded \$2K.

Downrange Safety Beacon

The Board discussed downrange safety issues, i.e. it is impossible to see a person in certain downrange areas from the rifle line. Doug suggested that ECSA purchase a safety beacon that could be turned on when a person is downrange for maintenance or any other reason. The Board approved \$350 to purchase a safety beacon.

VFW Scholarship

Kim Hutchison reported the VFW sponsors three \$1000 scholarships each year. They want to change that to one \$10K scholarship in the second year of college if the VFW can get other sponsors including ECSA.

Cowboy Shoot

Kim requested that the Board approve a Cowboy Shoot on the first Sunday of the month to be held at the ECSA range. The sponsors of the shoot will maintain their own equipment. After a
