Combined Board and General Meeting Minutes

Date: April 9, 2019

Board Meeting called to order at 6:40 pm

Range Status

Doug Wickre reported there is flooding around the culvert as you approach the rifle range. Doug shared pictures which showed the top layer of rock has washed away exposing the larger base rock underneath. The road is still usable but a larger culvert will need to be installed to replace the two existing 18" culverts and $\frac{3}{4}$ minus rock added to cover the exposed base rock.

ECSA may be able to do the repair work as Doug has a friend with a backhoe. Doug will begin looking at materials costs for the culvert and $\frac{3}{4}$ minus rock. Doug noted that a rock slope needs to be built on the back of the trap bunker as well.

Clarence Norton reported the left front tire on the tractor is flat and needs to be fixed. Doug stated he mounted the new trail camera near the front gate and installed one of the video surveillance signs.

Insurance Payment due

The General Liability and Physical Building Insurance policy is due for renewal. Farmers Insurance presented a renewal quote in the amount of \$2529.42 which would cover the pistol range, rifle range and the trailer. Payment was approved by the Board and a check was issued. Coverage for the generator and generator shack was discussed. These items may be added at a later date but pictures and descriptions will be required.

Activities will include a 100-yard .22LR AR shoot (\$1.00 per shot), a Texas Hold 'em poker shoot, a trap shooting demonstration, a muzzleloader demonstration and shooting, games for the kids and a gun raffle (everyone gets a free ticket at the door). There will be two gunsmiths available as well to perform gun inspections and safety checks.

The gates will open and registration begins at 8:00 am. Activities begin at 9:00 am and the event will wrap up around 4:00 pm. Doug Wickre will confirm that Gary Betscheider with the Stubborn Mule will provide a catered BBQ lunch. Doug will also confirm an NRA donated .22 caliber pistol for the gun raffle.

Tyler Hauck is creating the poster for the event and is also working on a new colorized version of the ECSA logo which could be used to create patches to be sold for application to jackets, hats, etc.
