### **ECSA Insurance**

Matt Howard and Les Bridges discussed the ECSA general liability insurance policy. The policy is an NRA endorsed policy that is based on approximately \$8/member. In addition, a policy that covers personal liability of directors and board members was discussed. Both present and passed board members would be covered.

On a motion by Clarence Norton and seconded by Dave Kuhlman the board voted to purchase this policy.

### **New Business**

#### **Trash and Brass Buckets**

The board discussed volunteers to periodically empty the trash and recycle the brass buckets. Brass buckets need to be sorted into steel, aluminum, and brass for recycle. Bob Jones volunteered that the sheriff's work group could be used to do the sorting.

#### **Prescribed Burn**

Matt Howard, Department of Forestry, discussed the recent fire at the range. Based on his assessment, Matt concluded that the fire was caused by an unusual coincidence of dry weather, wind, and bad target steel. Matt recommended a prescribed burn out to the 500 yard berm and that 10-15 feet in front of the targets be sterilized. He offered that the burn could be supervised by the Department of Forestry as a training exercise. No date was specified, but the burn would be scheduled as soon as possible based on weather conditions. He also recommended that the range be reopened until 12:00 noon because weather conditions were no longer critical.
