### **Last Month's Minutes**

The November minutes were read and approved on a motion by Dave Kuhlman and seconded by Andrew Sinclair.

### **Treasurer's Report**

The Treasurer's report was read and approved on a motion by John Wright and seconded by Clarence Norton. ECSA membership is now at 386 voting members.

### **Old Business**

#### **Range Report**

Doug Wickre provided a recap of the recent work Gary Bethscheider has completed at the range which includes grading around the vault toilet and rifle house, dressing up the 100-yard berm, and setting the new steel brackets at the 100-yard line which will support the uprights for the new wood target stands. Yet to be completed is the installation of the timber uprights and the 2"x6" horizontal boards. When finished, there will be a new target stand for each of the eight shooting benches.

Bill Botelho raised an issue involving the need for a separate 100-yard bay for sighting in only. Bill said the range is often busy and when a precision shooter is sighting in and checking scope tracking, the range must be shut down frequently to check targets. A separate sight-in bay might alleviate this issue. He will prepare a proposal for presentation at the January meeting.



### **New Education Building Project**

Doug Wickre reported that he has spoken with attorney Rebecca Knapp. She can provide legal services for the ECSA at \$250.00 per hour, and paralegal services at \$125.00 per hour. Rebecca can file the ECSA corporate papers each year for \$250.00, which includes the \$100.00 filing fees.

There was a motion made to use Rebecca Knapp, but Bill Oliver recommended we speak with other attorneys as well to see if we can get a better rate. Gary Bethscheider made an amended motion to go ahead and use Rebecca Knapp for the annual filing and give Bill one week to research other attorneys. The motion was seconded by Doug Wickre and passed.

Regarding the status of the Shared Use Agreement between ECSA and ECSEA for use of the new building, which was prepared by Steve Wolfe, the document is still with Paige Sully, pending her review.

There was a question from the audience as to the definition of Shared Use Agreement. Doug Wickre responded with an overview of the document.

#### **Board Nominations and elections for 2021-2022**

Doug Wickre asked the audience if there were any final nominations for the open Board positions. Nominations for Gary Bethscheider for Vice-President, Adam Saxton for Director, and Ken Hauxwell for Director were received, and the names were added to the ballots.
