**RELEASE OF CLAIMS, WAIVER OF LIABILITY, INDEMNIFICATION,
AND ASSUMPTION OF RISK AGREEMENT**

Indemnification. THE UNDERSIGNED, _____, a MEMBER of the Eagle Cap Shooters Association hereby agrees to indemnify, hold harmless and defend Eagle Cap Shooters Association, an Oregon non-profit corporation, Eagle Cap Shooter's Educational Alliance, an Oregon non-profit corporation, and their respective instructors, contractors, officers, members, employees, volunteers, and agents (Collectively referred to as "ECSA"), from any and all fault, liabilities, expenses, claims, demands or lawsuits arising out of, related to or connected with my presence at and/or participation in any course of instruction, any shooting competitions, the discharge of firearms, any and all of my acts and/or omissions, and any and all acts and/or omissions of a third party arising out of, related to or connected with ECSA's range, buildings, and premises (hereinafter "ECSA's Shooting Range") and my presence on or use of ECSA's Shooting Range, including any latent defects in the buildings or premises.

Release of Claims. Volunteer Hours

A Range Maintenance Fee of \$40.00 per year is assessed each member. However, members can offset the fee by providing 4-hours of volunteer work during the membership year. Volunteer hours may be accrued during the year by volunteering for a variety of tasks including but not limited to:

- Range maintenance, cleanup, and improvement projects
- Helping with setup, staffing, and teardown at ECSA events
- Serving as a Range Safety Officer for shooting events
- Assisting with solicitation for donations and prizes
- Helping distribute ECSA advertising flyers and brochures, and more. There are many ways you can help!

Volunteer hours may be earned by any ECSA member at \$10.00 per hour, up to a maximum of 4 hours. No limit on hours for time worked on the new clubhouse project, all hours worked can be deducted. Volunteer hours cannot be carried over from year to year. Volunteer hours cannot be applied to event fees. Volunteer hours are recorded on the Record of Volunteer Hours cards and submitted to the Treasurer who tracks the hours and maintains the records.
