## **Last Month's Minutes**

The September minutes were read and approved on a motion by Ken Hauxwell and a second by John Amond.

## **Treasurer's Report**

The Treasurer's report was read and approved on a motion by John Straughan and a second by Dan Moncrief. Current checking account balance is \$12,908.55 and current savings account balance is \$10,401.88 as reported on the handout. The detail of the Treasurer's report is available by contacting John Amond. A check in the amount of \$100.00 was mailed to Mike Musia for reimbursement of fuel. For fire safety, Mike provided a water truck for the August MVPA dry camping event.

## **Membership Report**

The current annual membership as of August 15<sup>th</sup>, is 279, plus Life and other memberships of 57 for a grand total of 336.

Gary Bethscheider led off a discussion about membership fees. Gary proposed adding back the 10-year membership and creating a 5-year membership. Gary suggested raising membership dues \$10.00 every year until the cost of a single membership reaches \$105.00. Gary would like to see the removal of the 4-hour maximum cap on volunteer hours as well. This would enable members to "work off" their entire membership dues, and/or provide a reduced rate or free membership for someone else. It's been a

Dan Moncrief proposed increasing value of volunteer hours from \$10.00 per hour to \$15.00 per hour which would move the Range Maintenance Fee from \$40.00 to \$60.00 per year. Bill Oliver tabled the matter with the understanding that there will be a full discussion at the December 20, 2022 meeting.

## **Law Enforcement Relations Report**

Jamin VanMeter's Oregon State Police SWAT training today went very well according to Bill Oliver. OSP will be training again tomorrow. Jamin told Bill the SWAT members used the 100-yard moving target range which is not quite finished but he was still quite pleased with it. OSP is looking forward to using it again next year. Jamin said OSP will likely use the ECSA range next June for Sniper School, with 40 to 60 participants.

<u>9/24 Machine Gun Shoot, MJ Van Dine-Host</u> – There were a few people attending who shot some of the full-auto firearms provided by Iron Ordnance.

<u>9/25 Hunter Sight-in Day, Clayton Lowe-Host</u> – Several shooters showed up to sight in their rifles for hunting season. This was better attended than the 9/18 sight-in day Kim Hutchison hosted, where no shooters showed up.

10/2 Curios and Relics Fun Shoot – Kim Hutchison, Host – There were only four shooters attending but it was still a fun event. Kim also provided a detailed written report of the 9/17 Youth Shoot (see Appendix A). Bill Oliver thanked Kim and his wife Holly for all the hard work setting up and hosting the Youth Shoot.

## **Range Report**

Gary Bethscheider has completed final excavation of the recessed walkway for the moving target range. Gary said the walkway will need to be rocked before the snow sets in. Gary has secured 30 concrete Jersey Barriers currently located in Baker and he is trying to get them picked up and delivered.

Adam Saxton proposed keeping the competition bays open for use all the time vs. only for formal events. After some discussion, the consensus was unanimous to keep them open and remove the sign that indicates they are closed.

Dan Moncrief reported that the springs on the steel plate rack target at the pistol range have been replaced. Dan said target backers still need to be placed on the target stands at the rifle range.

Bill Oliver stated the new Promatic Signature Double Wobble trap machine has arrived at the range and

The Board will consider all loan proposals at an Executive Session after the November 15, 2022 general meeting to determine which proposal to submit to members for final vote.

Shoot started with a 0900 signup at the new Club House and began at the Pistol Range. There were three courses of fire at the pistol range. One at the rifle range with open range on the shooting when contestants were done.

New this year, we had a pistol event for the 13-17 age group. The course of fire was five rounds from a pistol at a steel target at 25 yards; five rounds at playing cards at 50 yards for the poker hand; five rounds at the bowling pins at 25 yards; and 10 rounds at the "Test Your limits" targets at 15 and 25 yards. Scoring was best poker hand on face up cards and hits for the rest of the events.

We had 19 shooters with parents and other family member attend. Weather was cool in the morning but warmed up nicely during the shoot. Lunch was served in the new Club House and was hot dogs, homemade soup, chips, soda, and coffee.

There were very little safety reminders given during the shoot. The participants listened to the safety briefing and practiced safe gun handling skills throughout the shoot.

## **Appendix B**

## **Conditional Commercial Loan Approval**

) Borrower: Wallowa gun club?

Lender: Richard Shaw

) Amount: \$100,000.00 less 1% loan fee deducted at closing.

) Loan purpose: Bringing electrical power to the facilities.

- ) Loan interest rate:7% per annum for 5 years. (payment= \$707/ month) At the end of that period the remaining balance will be recalculated using the previous month's annual CPI plus 3%; (however not to be less than 7%) for an additional 3 years.
- ) Amortization period: 25 years for the first 5 years. 20 years on the remaining balance for the 3 additional years; after which the final balance will be due.
- ) Loan security: 1st unencumbered trust deed on the gun club real estate; including all equipment and facilities used in its normal operation.
- ) Borrower pays all closing costs.
- ) Borrower to provide to lender previous 3 years tax returns and financial statements.
- ) This loan is conditioned upon a satisfactory Title Report. And lenders approval of financial statements.
